Compliance education

In 2013, the process of both extracting risks associated with inventory management operations and developing responses to them was concluded. This was part of the second project dealing with the creation of internal control systems. In 2014, we will move forward on internal

controls that address our current procurement operations. Each half year we conduct education for executives on legal compliance



Human Rights

Human rights education

Employees are recruited irrespective of race, religion, nationality, gender, appearance or age. Screening and interviews are conducted pursuant to company regulations and excellent human resources who satisfy our employment standards are selected. Note, that in accordance with local laws, we do not engage in the employment of minors.

Promotion of gender equality

China is a country of gender equality and a competent person can be promoted as wages and promotion are determined regardless of gender. Among managers of the company, there are three female department general managers and five female section managers.

Employment of people with disabilities

We actively employ people with disabilities corresponding to recommendations of the national government. We now have 20 people with disabilities and have been commended as a model company employing people with disabilities in Hangzhou in 2013.



Labor Practices

The safety and health of all employees represents the foundation of CHZY. We are a company that is trusted. This trust comes from the zero danger that we derive through our operation of an occupational safety and health management system, which is achieved through the cooperation of all employees as we work together to build a safe, healthy and comfortable workplace.

Safety and health policy

- 1. In compliance with laws and regulations and based on internal regulations and standards, we will ensure the safety of all employees.
- 2. We will build safety through equipment.
- 3. Safety awareness
- 4. Raising awareness at all times
- 5. Company executives will be the model.
- 6. Build up a safety culture of CHZY through these activities.

Targets

- Zero accidents which are severer than minor injuries
- Our operations have received China State Safety Standards Grade 2 Certification, and we are currently preparing for the Grade 1 inspections.



Education and training for employees

The Company President displays an attitude of safety education in morning meetings. We established a safety sensory training room and safety training is provided not only for new employees at the time of entering the company but also for all employees once a year.

Safety awareness of all employees is evaluated not only for employees on sites but also for employees working in the administrative department. We have been stimulating safety awareness of all employees by deploying KYT (danger anticipation training) activities.

CHZY has been recognized by the Hangzhou Development Zone as a Safety Model Company based upon the safety results it has achieved thus far. The company also obtained Japanese Occupational Safety and Health Management System (OSHMS) Certification in 2012. The OSHMS standards exceed those demanded by government. In 2014, we also passed a China State Safety Standards Grade 2 Certification re-audit. Looking towards the future, we are preparing to pass the China State Safety Standards Grade 1 Certification.

Responses in case of disasters

- The department in charge of safety and the person in charge of firefighting at each department conduct periodic inspections every month and the operation status of fire-fighting system and results of inspection of the fire-fighting equipment are reported at the safety meeting.
- In preparation for a power failure, an engine pump is installed in a product warehouse and operation inspection is conducted every month.
- We conduct fire-fighting and evacuation drills for all employees every year.
- We conduct exercise drills in case of occupational accidents every month.

Promoting environmental management

We aim at being a company having world class technologies to protect the environment, which is trusted by all employees, their families and Chinese society. We will further contribute to Hangzhou as a modern highly civilized city.

- 1. We comply with laws and regulations and take sufficient preventive measures against environmental pollution.

- 3. Using the ISO14001 Management System, we promote continuous improvements.

Status of Management of Chemical Substances (Response to PRTR Law)

China promulgated a new law on management of discharges of chemical substances in April 2013. We will respond to chemical substances in accordance with detailed regulations for implementation. For example, with respect to packaging that contains chemicals such as sulfur, etc., such will be disposed of using contractors who specialize in the disposal of chemical waste. These contractors will have the necessary qualifications to handle such work.

Noise, vibration and odor

We periodically measure noise and vibration to improve problems and take measures such as installation of sound insulating walls. For odor countermeasures, dry deodorant devices has been employed for the first time by Yokohama Rubber, which are installed in all mixers in the mixing process, which has resulted in a reduction of 80% of odors. In order to address further reductions in exhaust gas, we are promoting installation of roof exhaust deodorant devices for the vulcanizing process, which will be completed by 2013.

As a model company of waste reduction, we completed a sewage treatment facility in May 2013. For discharge waste water, we comply with standards of the Chinese Government.

CSR Policy

We perform social responsibility in order to become a model company of compliance and develop personnel with a strong CSR awareness while formulating a basic system of internal control to prevent risks.

 We aim at zero corruption. With respect to the purchase of materials and outsourced construction, etc., we prevent the occurrence of unjust acts by a purchase system of application for purchase, estimation, approval and placement of orders.
