* Greenhouse gas emissions in FY2009 were calculated based on the Calculation and Reporting Manual for Greenhouse Gas Emissions jointly published by Japan's Ministry of the Environment and the Ministry of Economy, Trade and Industry (METI).

Despite the increase in production levels, waste output by volume fell steadily due to the success of our zero emissions program. Greenhouse gas emissions likewise decreased 11% relative to last year.

Daily safety inspections are carried out under the Health and Safety Policy, and OHSAS 18001 occupational health and safety management system is being introduced.




Assisting with disaster relief efforts
