Key Activities at Group Companies

YOKOHAMA RUBBER MBT CO., LTD.

We are pursuing a range of strategies and initiatives to achieve the environmental objectives of the Yokohama Rubber GD100 medium-term management plan. In a bid to further enhance these efforts, we also obtained the external qualification known as Michinoku EMS, a local environmental management system for businesses operating in Miyagi prefecture and the city of Sendai. Michinoku EMS has mutual recognition arrangement with other qualifications such as KES, a simplified environmental management system designed for small to medium businesses. Although the certification process posed many difficulties at first, particularly the unfamiliar terminology ("environmental aspects," "corrective action") and complex internal auditing procedures, the combined efforts of all employees helped to ensure its success.

There were three key stages in the certification process:

- 1) Identifying environmental aspects in every division and department and formulating targets for reducing industrial waste and promoting environmentally friendly products.
- 2) Implementing modifications in our warehouses in accordance with legal requirements, including labeling of industrial waste receptacles and storage labeling for designated flammable substances.
- 3) Appointing an internal auditor and conducting an internal audit in December, followed by the final screening in February that led to successful certification.



Qualification Certification for the Michinoku Environmental Management System

YOKOHAMA RUBBER MBK CO., LTD.

Yokohama MBK is working to eliminate wastage in production processes and pursuing three main environmental programs predicated on reducing the environmental impact through a results-oriented management approach

- (1) Reducing paper usage via double-sided printing
The volume of A4 copy paper purchased fell from 640,000 to 547,500 sheets.
 - The paper saving of 92,500 sheets represents the cumulative total from April 2009 to January 2010, compared to the same period in the previous year.
- (2) Reducing electricity usage
Removing unnecessary fluorescent tubes (merger of office space with Head Office in September)
The number of fluorescent tubes was reduced from 376 to 232, a reduction of 144 (as of April 2010).
"Black Illumination" campaign (every Friday since July)
- (3) Reducing waste output, water and electricity usage, and petrol consumption
